60x20m arenas for grades 1, 2 & 3 – 40x20 for grades 4, 5

1. Dressage Sashes to third place (must compete in all phases to be eligible)
2. Medallions 1st – 3rd overall
3. Sashes 1st -6th overall

Conditions of Entry:

1. Entry Fee is: \$35 per PC entry(Includes \$5 Facility fee per horse)
\$45 per open entry (Includes \$5 PCAV Levy and \$5 Facility Fee).
2. All sections conducted under the latest PCAV Horse Trials Rules 2010, including amendments.
3. Non-PCAV members competing in the open section must sign a day attendance form and pay a \$5 fee before riding (inc. in entry fee) & fill in horse tracing details (included on entry form).
4. Medical armbands and back numbers are compulsory in all phases. Back numbers will be provided. Armbands must be inspected at gear check for each phase.
5. Approved riding helmets to be worn – as per PCAV gear rules 2010 (No's. AUS/NZ 3838, EN1384, ASTM F 1163). Helmets may be subject to spot checks.
6. The organising committee, BPC Inc reserves the right to cancel any event; divide classes; alter times; refuse any entry with or without stating the reason. Special requests considered but may not be granted. Decisions of the organising committee are final.
7. All riders must pay a \$4 per horse facility fee (included in entry fee) which goes towards grounds maintenance.
8. PCAV membership cards must be presented, when collecting back numbers, and must show 50% attendance or 25% if over 17 years, in the previous 12 months and at least two rallies on the horse entered.
9. Protests must be lodged with jury of appeal, within 30 minutes of the final scores being posted and accompanied by a \$50 non-refundable deposit. Queries, protests, horse abuse and doping rules as per PCAV Handbook of By-Laws 2010.
10. All competitors must present for gear check at least 15mins prior to each phase.
11. No refunds after closing date except with vet or medical certificate submitted within 7 days of competition (a \$10 admin fee will be deducted).
12. Competitors may ride more than one horse competitively in grades 1, 2, 3 subject to ballot of entries. Preference will be based on listed order on entry form.
13. Pony Club uniform to be worn for all phases including presentations.
14. Entering this competition constitutes acknowledgement that PCAV rules apply and acceptance of these rules.
15. **DOGS ARE PROHIBITED WITHOUT EXCEPTION – PENALTY OF ELIMINATION.**
16. Lunging is **ONLY PERMITTED** in the nominated **ENCLOSED** area (**ROUND YARD**) as per PCAV rules 2010 – breach many result in elimination.
